Backgrounder
Home Energy Savings Program (HESP)
For Homeowners with Low Income Using
Diesel Generated Electricity* or 1,000+ Litres of Oil Annually
***Communities served by diesel systems.**

What is the Home Energy Savings Program (HESP) ?

HESP is designed to assist homeowners with low income in making energy efficient retrofits to their homes. The program assists clients with retrofits that will make their primary residences more affordable and reduce greenhouse gas emissions that contribute to climate change.

What assistance is available under HESP?

Newfoundland and Labrador Housing Corporation (NLHC) will provide a pre and post-energy inspection.

For owners of single, row and semi-detached housing, assistance is available in the form of a grant up to \$5,000.

Condo owners are not eligible for HESP assistance.

What repairs or renovations qualify under this program?

The dwelling must be your primary residence. All repairs will be identified through an energy evaluation, which will determine the best possible solutions for energy efficiency. A post-energy evaluation will also be required to confirm that identified work was completed. Examples of some repairs that will create energy efficiency are: basement and attic insulation, and draft-proofing.

Who is eligible?

Homeowners with incomes of \$32,500 or less per year who use diesel generated

electricity* or 1,000+ litres of oil annually may be eligible. Proof of annual consumption can be obtained from your electricity bill(s) or fuel-oil bill(s). Proof of home-ownership must be provided with the application to the satisfaction of NLHC. Homeowner(s) must provide consent to allow NLHC to receive income information from Canada Revenue Agency. Incomplete applications will be returned.

If you have already received Residential Energy Efficiency Program (REEP) assistance, you are not eligible to apply for HESP.

Annually, NLHC will be able to assist approximately 450 clients.

How are eligible homeowners selected for the program?

Applicants will be served on a “first-come, first-served” basis. Applications can be dropped off at any NLHC office and will be date stamped when received, or if mailed, the post-mark date will be used.
